**ABSTRACT / ABSTRAK**

The Health Social Security Organizing Agency (BPJS) is a legal entity to organize a social security program to ensure that all people can meet the basic needs of a decent life. For this reason, the government plans to remove the BPJS Kesehatan classification based on the class that is currently valid to a single class called a standard inpatient class (KRIS) or standard class. Community service will be held on October 1-5, 2021. The results of community service show that the existence of BPJS Kesehatan is very helpful in obtaining health services, but there are still many people who do not know about the policy of the BPJS Kesehatan standard class that will be applied. After the community service explained what is meant by standard classes, many respondents objected to standard classes and preferred grades 1, 2 and 3.

## 1. BACKGROUND

The Standard Inpatient Room is one of the efforts to provide health insurance according to the principle of social insurance and the principle of equity. The goal is for JKN participants to get the same and standard inpatient room services throughout the hospital. Currently, the hospital still uses the BPJS 3-class system, in the future it will be applied to a single tariff, namely the standard class.

In organizing health insurance for all Indonesians, Law No. 40 of 2004 concerning the national social security system was made. The National Social Security System Law provides for the implementation of health insurance, work accident insurance, pension insurance, old age insurance, and death insurance for the entire population through mandatory workers' dues. In its implementation, it is carried out by the Social Security Organizing Agency (BPJS). In article 23 paragraph 4, it is explained that the services of participants in the hospital are provided in accordance with the standard class.

In carrying out Law No. 40 The year 2004 did not fully go perfectly. In its implementation, participants have received health services according to their needs in accordance with the principles of justice. However, the standard class contained in article 23 paragraph 4 of Law No. 40 of 2004 still does not have criteria that can be applied in all hospitals. Therefore, this standard class is a priority in the National Health Insurance Map 2012 to 2019, which is expected to create a standard class in 2019. (Indonesian National Health Insurance 2012).

In its application, until now it is still not working as it should. In the implementation of BPJS 3 classes, inpatient rooms between hospitals are different. The standard class still does not have established criteria, so to equalize the standards for the creation of fair and equitable acquisition of health facilities, Law No. 47 Year 2021 concerning the implementation of hospitals. Article 18 says standard inpatient rooms are at least 60% for government hospitals and 40% for private hospitals. Article 84 letter breads that standar inpatient services are applied no later than January 1, 2023.

## 2. METHOD

Data collection was carried out using the in-depth interview method of informants who were used as participants in community service. There were 20 participants in this service. The participants of this community service are health service implementers who are hospital management which is directly related to the 22 participants of BPJS Kesehatan, budget planning, service planning, and planning hospital infrastructure. This community service had a total of 20 participants from the management of Abdoel Wahab Sjahranie Hospital. Participants came from the Coordinator of the Service Unit (KSP) mobilization of funds, Hospital Facilities Maintenance Installation Staff (IPSRS), Head of Inpatient Installation, Planning and Budget KSP, and Occupational Health and Safety (K3) KSP. The representatives of each section have represented all the planning in preparation for the implementation of KRIS at the Abdoel Wahab Sjahranie Regional Hospital.

**3. RESULT AND CONCLUSION**

In this community service, it is to describe socialization of standard inpatient classes (KRIS) to employees of Abdoel Wahab Sjahranie Hospital. In this community service, the service gets data and information related to standard inpatient classes (KRIS) to employees when assisting the health administrator.

Based on table 2, it can be concluded that the presentation of health administrator standard inpatient classes (KRIS) to employees of Abdoel Wahab Sjahranie Hospital who are present is 20 respondents (100%), while those who are not present are 0 respondents (39.8%).

Socialization of standard inpatient classes (KRIS) to employees of Abdoel Wahab Sjahranie Hospital is an important part of the company both at Abdoel Wahab Sjahranie Hospital in establishing operational activities to achieve goals in the Hospital. The socialization function of standard inpatient classes aims to provide services so that the process of cooperation towards achieving BPJS planning from before.

Description of the socialization of standard inpatient classes (KRIS) to employees of Abdoel Wahab Sjahranie hospital, namely health administrators are obliged to provide public good health services and are also obliged to facilitate the development of private health services. Thus, the health administrator is in charge of regulating, fostering and supervising the implementation of health efforts that are equitable and affordable to the community, mobilizing community participation in the implementation and financing of health while still paying attention to social functions. Like the administrator, it is expected to be able to carry out its duties and functions at the Abdoel Wahab Sjahranie hospital.
